### "Winter Photography" with John Stier

What could be more fitting in early December than a "Winter Photography" Program? That's what **John J. Stier** will present on Tuesday, Dec. 7. He will inspire us to keep shooting through the Winter months by providing helpful tips on how to prepare for cold weather and snowy conditions.

His slides will show how he has applied his Winter photography expertise to city snow scenes, icy abstracts, moonlit snowscapes, wonderful shadows, and spectacular landscapes. The locales of the images include area lakes and streams, Canadian Rockies' back country, Colorado ski towns, distant Norway, and the Yellowstone wilderness.

John and his wife, Barbara, are avid cross-country skiers. It is his love of skiing that provides the opportunities to photograph these beautiful and often remote settings. Originally a native of Florida, Stier is an accomplished photographer residing in Columbia, MD. His publishing credits include Peterson's Photographic Magazine, and the prestigious Stephenson Calendar, BlueRidge Country Magazine. He has also been published in textbooks and newspapers, including the Baltimore Sun. There is an article on him in the current Dec. issue of Popular Photography magazine.

John has won numerous awards in local and national competitions. They include First Place Photography in the Nov. 1992 Art League Member Show (Torpedo Factory); Grand Prize Winner in the April 2003 Apogee Photo Magazine "Winter" contest.



# Third Annual Meadowlark Nature Photography Exhibition

Feb. 11, 12, 13, 2005

NVPS is one of six Northern Virginia camera clubs that are participating in the Meadowlark Photo Exhibit that will be held in the Atrium and Visitor Center at Meadowlark Gardens on Feb. 11, 12 & 13, 2005, from 10 a.m. – 4:30 p.m. Feb. 11 is reserved for special guests. Saturday and Sunday are for the general public. The exhibit will be held in the Atrium and sponsor tables will be located in the Visitor Center. Educational programs will take place on Saturday and Sunday. A private reception for the exhibitors and their guests will occur on Saturday evening. Meadowlark Botanical Gardens is off Beulah Road, between Rt. 7 and Rt. 123, in Vienna, VA. For info visit: www.meadowlarkphotoexhibit.com

Each club is limited to 125 entries, including framed and unframed works. Although the six participating clubs can submit a total of 750 entries, only 175-200 prints can be shown at Meadowlark. This works out to be an average of about 30 per club. Table space for each club's unframed pieces will probably accommodate 20-30 prints at any one time. Limited space for framed pieces (about 5 linear feet of wall space and one floor easel per club) is available. (Metal frames should not be clip frames, but should be well constructed, such as the Nielson frame.) Any exhibit space (table, wall, or floor easel) unused by one club can be used by another club. If a club has more juried-in photos than can be exhibited on its table or wall space at any one time, that club will decide on how to rotate its members' work during the time period of the exhibit. Each club will set up its exhibit on Thursday, Feb. 11 during the late afternoon and evening. The exhibit space will be prepared prior to the set-up time.

### **Great Blue Heron Contest**

This contest is sponsored by the Northern Virginia Regional Parks Authority (NVRPA) and will be held at the same time as the Meadowlark Photo Exhibit, in a small room at the Atrium. Due to limited space, each club may enter one photograph of great blue herons. Submitted prints must meet the same matting rules as for the Meadowlark Exhibit. Visitors to the Meadowlark Exhibit will be given tickets by which they will vote for their favorite great blue heron print. It is being decided whether entries shall be limited to photographs taken in Virginia and within the past 12 months.

### **Collection of Prints**

Entries for the Meadowlark Nature Photography Exhibit will be collected at the Jan. 18 and 25 meetings. NVPS members can submit as many prints as they wish and should provide a list of their prints in order of preference for selection. Entries can be submitted in UNSEALED clear plastic envelopes. Any prints that do not meet the exhibition requirements (the theme and the matting/presentation guidelines) will be eliminated. If the remaining prints total 125 or less, then all the prints will be submitted as the NVPS

entry. If the total number of prints exceeds 125, the NVPS entry will be selected by taking one from each person's entry list and continuing to pass through each person's list in this manner until 125 have been selected. Thus the first pass will include each member's first preference, the second pass will include each member's second preference, and so on. Entries for the Great Blue Heron Contest will also be collected at the Jan. 18 and 25 meetings. If more than one print is submitted, the NVPS entry will be selected by a club vote at the Jan. 25 meeting.

# Resources for Matting and Framing Prints

The idea of matting and framing your prints is less intimidating if you know about local and mail order resources for obtaining the materials or for getting parts of the process done for you. A couple local resources for mat board are: Pearl Art Supply (located at the corner of Telegraph Road and North Kings highway) and FrameMasters (on Merrifield Ave in Fairfax). A 4-ply thickness is appropriate for mats 16 x 20 inches or smaller. Various materials can be used for the backing, including 2-ply mat board or archival (acid-free) foam core. You can also order whole sheets of mat board from various mail order sources, such as Light Impressions or Daniel Smith—however a minimum number of sheets may be required. Mat board typically comes in 32x40 inch boards, so one piece can make several medium to small mats and can be shared with others.

If you don't want to cut your own mats, you can have mats cut to your specific dimensions by local framing shops or by mail order. Light Impressions sells archival pre-cut and pre-hinged mats. Precut mats available at Pearl or other retail outlets are not a good choice because usually have a border narrower than 2 inches (which does not make the best presentation) and because, although the label says "archival," the core of the mats are not made of true archival materials.

If you cut your own mat, you will need tape, such as linen hinging tape, for hinging the window mat to the backing. Attaching the photograph to the backing



### **Mark Hyett Featured**

I have a collection of snapshots that are almost as old as I am—frozen moments in time captured throughout my existence. It is an incomplete compilation filled with out-of-context images that are often faded and tattered. The people and locations contained within are sometimes unknown as are the dates. These snapshots largely tell a story of who I am and where I came from. Unfortunately, I cannot share these images with others, as they are my memories... literally.

I have another collection of snapshots that are also almost as old as I am. These also represent a random selection of people, places, and events throughout my life. Many of these images are also tattered and faded. Often, the context is no less obscure, the people no more identifiable, nor the places more familiar. However, these memories can be shared.

Often, I find it difficult to separate the two collections and the older I get, the less I can distinguish between them. Many times, I find an old photograph

that I was so sure was an actual memory but was not. Other memories seem to be photos but no such photograph can be found. The two collections are so tightly intertwined together that they become one and the same. Experiences happen in an instant; memories and photographs last considerably longer.

At age seven, I started out with a Kodak 126 Instamatic camera and gradually worked towards 35mm SLR systems. In high school and collage, I spent about five years processing my own B&W film and prints until I lost access to the free supplies and darkroom.

The loss of the darkroom access and hence the loss of control over the printing process was devastating and I quickly lost enthusiasm for photography. I did not care for slides as they were difficult to enjoy on a daily basis. For a few years, photography took a backseat to graduate school and career, until I met my wife Yufen who also had an interest in photography.

After a few more years of suffering through the McPhoto labs and their mechanical processing, I discovered digital photography in the Fall of 2001. I haven't shot a roll of film since. Going the digital route gave me back total control of the printing process—something that I had in the darkroom. The ability to adjust the images (something that every photo lab

attempts to automate but never seems to get right) goes a long way towards producing the final photographs that I desire. Being able to immediately print the results is just icing on the cake. I never once missed film.

My photographic habits have changed over the years. Abstracts, macros, street photography, and architecture were all once part of my past. More recently

I have concentrated more on nature and travel photography. Portrait photography is something that I am beginning to branch out into as well. In short, I like experimenting with different photographic techniques and styles.

In order to nurture the memory making process, Yufen and I

enjoy traveling frequently. During our trips, much of our time is spent on photographic endeavors. Yufen scopes out the big picture looking for photographic opportunities while I have my face pressed up against the camera working each subject extensively. And yes... I usually do carry my own camera bag.

While out in the field, there are two types of photographs that I attempt to capture: those that I might hang on the wall and those that I might place on my desk. The wall photos are the ones that are pleasing to look at; artistic attempts at imagery that end up in my portfolio. The desk photos are the ones that are pleasing to remember; pictures that end up in my family photo album and become my future past memories.

Somewhere between my past memories and my future past memories lies my present day experiences and photographs. These I share with the world at **www.PhotographyByHyett.com**-I hope that you will enjoy viewing them as much as I enjoyed photographing them.

### **How This Photo Was Made!**

My friend Myke in Fort Lauderdale, Florida asked me years ago to shoot some bubble bath photos in her new condo. On the technical side, I used a manual Nikon FM2 35mm film camera loaded with a roll of Kodak ISO 400 color negative film, and shot with a 50mm normal lens. A Nikon diffusion filter was used to soften the image.

For the lights, I mounted two small shoe-mount strobes on one lite stand that holds two flashguns. I aimed both of them into the upper left corner over my left shoulder and fired them by a remote radio

slave triggered by the camera. The lights were set to manual full-power to light the whole room, and bounced into the corner to spread the light around for a soft even lighting effect. The camera was tripod mounted low to the floor and fired with a cable release at about  $1/60~{\rm sec.}$ 

No F-stop was remembered. We filled the tub with warm water, poured two bottles of bubble bath in, she stepped in and we then "fixed/moved" the bubbles as needed and shot the one roll. What I like best about the photo is that it came out exactly the way I wanted it to. Pre-visualization is so much fun!





# From: Transportation Security Administration

### Transporting Film and Photographic Equipment

You may carry one (1) bag of photographic equipment in addition to one (1) carry-on and one (1) personal item through the screening checkpoint. The additional bag must conform to your air carrier's carry-on restrictions for size and weight. Please confirm your air carrier's restrictions prior to arriving at the airport. Air carriers may or may not allow the additional carry-on item on their aircraft. Please check with your air carrier prior to arriving at the airport.

The equipment used to screen checked baggage will damage undeveloped film. Pack your undeveloped film in your carry-on bag. High speed and specialty film should be hand inspected at the security checkpoint. To facilitate hand-inspection, remove your undeveloped film from the canister and pack in a clear plastic bag. The screening equipment will not affect digital cameras and electronic image storage cards.

### PICTURE PROTECTION COULD SAVE PLENTY

### From the Penn Camera "Pen Palz" newsletter of Nov. 2004

Picture this: What would happen if your house caught fire and most of your possessions were ruined? Could you recall all of your home furnishings and personal belongings in the event that everything went up in smoke? Most of us would overlook as much as we'd recall in our post-disaster memories. And that could cost us a fortune when dealing with an insurance company demanding documentation.

Here's a tip. Buy four or five rolls of 36-exposure film or a sizable memory card and go room to room, photographing everything, both in and out of sight. This means everything from couches and silverware to lawn equipment and bikes (and everything in between - bedroom sets to Grandma's china). Don't overlook those valuables tucked away for safe keeping in drawers, chests, boxes, and cabinets-items such as fine jewelry, and stamp collections.

Make sure to overlap your photographs so that you don't leave anything out. Open cabinets and closet doors. Check out the attic and basement. Look down in the crawl space (use flash, if necessary). For smaller items containing valuable information such as serial numbers, signatures, etc., use a close-up lens to capture the detail. Then caption the back of each photo, explaining exactly what each item is.

When you have the film processed or digital images printed, order two sets (very inexpensive from film when done initially). You could even have your images saved to a CD for record. Keep one set of prints on hand for quick reference, a second set locked securely in a bank safety security box or some other off-premises location.

Even if tragedy never strikes, you'll still have a valuable list of your family's belongings. But if it does, you'll be forever grateful that you took the time and effort to record your goods for replacement.

board can be done with mounting hinging tissue, archival photo corners, or various adhesive methods. These supplies are available locally from art suppliers like Pearl or Michael's, and by mail order from Light Impressions.

Matted prints can be transported and stored in archival clear plastic envelopes. One resource is Impact Images at: 800-328-1847 or at www.clearbags.com - They have all sizes with a tearaway strip to use for sealing. If you are entering the Meadowlark Exhibit and using the bags to protect your prints, leave the strip attached to the bag and leave the bag open. The 16x20 inch size sells for 26 cents per bag, but you must buy at least 100. However, you can divide the package and share the costs with other people.

Once you have matted a print or had it done for you, consider framing it yourself using metal sectional frames. Pre-packaged metal sectional frame kits are easy to assemble and come in a wide range of sizes that increase incrementally by one inch. Two packages are used for one frame — each package contains two frame pieces of the same length and half the hardware needed for assembling and hanging the frame. Pearl, Michael's, and The Frame Factory (Annandale and Vienna locations) are local resources for pre-packaged metal sectional frames. Metal sectional frames can also be cut to specific dimensions. Custom cut sections and hardware can be obtained locally at suppliers, such as FrameMasters and The Frame Factory, or by mail order from Light Impressions, Daniel Smith, and many other companies that specialize in frames and framing supplies.

Metal sectional frames come in a wide range of colors and styles, although the colors and styles available at Pearl and Michael's are limited. One advantage of these frames is that you can easily change the print that is inside the frame. One disadvantage is that the frames scratch easily, so you need to protect them when transporting them or assembling them.

The last step is getting the glass for the frame. Picture frame glass is sold at FrameMasters and Light Impressions. They carry clear and reflection control glass and glass which protects your photograph from UV damage. It is available in standard sizes or custom cut

### Photojournalist George Silk Dies at 87

George Silk, 87, a photojournalist who spent 30 years with Life Magazine, attaining fame for his coverage of WW II and later pioneering the use of a special camera for depicting athletes in motion, died of heart failure Oct. 23 in Norwalk, CT.

Mr. Silk, a New Zealand native, joined Life's photo staff in 1943 and spent the next two years covering the war on the Italian front, the Allied invasions of France and the Pacific. He shot the first pictures of Nagasaki, Japan, after the atomic bomb was dropped, as well as Japanese war criminals awaiting trial in postwar Tokoyo.

Mr. Silk's career as a war photographer began in 1939, when he was a combat cameraman for the Australian government, covering action in the Middle East, North Africa and Greece. Trapped with the famed Desert Rats at Tobruk in Libya, he was captured by **German Field Marshal Erwin Rommel**'s forces but escaped 10 days later. He was with the U.S. forces in the Battle of the Bulge in 1944 and was wounded by a grenade during a river crossing in Germany.

He was named magazine photographer of the year four times by the National Press Photographers Association. You may remember **George Silk** shown in a small spiral-bound handbook (4"x7")showing how to hold the 35mm camera when shooting from different positions.

### Fuji Digital Camera Problems

The following E-mail was sent to Fuji on Tuesday, Nov. 2, 2004 concerning a problem that I had with my camera during a recent trip to northern Canada.

On a recent trip to northern Canada, I experienced a problem with my S2 Pro camera. As the camera cooled down below freezing temperatures (0 degrees C), the image sensor appeared to be affected by severely overexposing the picture. The cooler the camera body became, the more the over exposure. As the camera warmed up, everything returned to normal. Is it normal for this camera to be affected by cold?

When the problem occurred, I set the camera to under expose by

2.5 – 3 stops; I could get an image that appeared to be 1.5 stops under exposed. With less compensation, the image was still severely over exposed. The lighting conditions at the time, I should have been setting the camera to over expose by .5 stops. I could verify this by viewing images shot by others in my party who were using Canon and Nikon digital cameras as well as film cameras.

As a side note, the first thing I checked was the batteries. When the problem started happening, I changed the batteries to a fresh set that I kept in an inside pocket of my jacket. The fresh batteries had no effect. In addition, all other functions seem to work normally.

Thank you for your help.

I receive an E-mail from Fuji the next day directing me to call technical support. On Thursday Nov. 4, I called Fuji technical support. The person that answered the phone was courteous and professional. The type problem I had with the camera is rare, but not uncommon. The specifications of operating temperature for the S2 Pro are between 32 degrees and 104 degrees. When the camera is in a cold environment for a prolonged period, the cold could affect the sensor's ability to record information or equally likely the program circuits that transfer the image from the sensor to processor and then the memory card. Since the camera started working correctly as it warmed up past 32 degrees, there was likely no problem with the camera. He also informed me where to look in the User Manual for the operating conditions specifications.
